Sedona Weekend Drawing (the "Drawing")

1. 5. Prizes, Approximate Retail Value ("ARV"): Total ARV of the prize in this Drawing is \$1000.00 USD. No substitution, cash redemption or transfer of prizes is permitted except at Diocese's sole discretion or as provided herein. If the advertised prize cannot be awarded for any reason, Diocese reserves the right to substitute a prize of equal or greater value. By participating in this Drawing, entrants waive all rights to claim punitive, indirect, incidental and consequential damages, attorneys' fees or any damages other than actual out-of-pocket costs incurred to participate.

9.
